- **A. Welcome** Council Chair Markus Ahrens and Director of Operations Barb Brady welcomed everyone to the webinar. Barb reviewed the webinar instructions and chat feature. Markus reviewed the agenda for the webinar.
- **B. Bylaws Update** Pat Poli gave an update on the Bylaws Project. Emails have been sent to the Sections informing them that their current bylaws and the proposed revisions have been posted to the Section websites for review. Voting on the revised bylaws will take place from May 14th through May 29th and will be done via the Member Dashboard on the AAA website. Emails will be sent to Section members when the voting opens. Region bylaws revisions are also underway and should be ready for a vote in the upcoming months.
- **C. Sustainability Mindset** Anne Christensen reviewed the Sustainability Mindset Matrix and the importance of focusing on projects that are "up and to the right," meaning that they have both a high level of impact and high profitability. Council was asked using Poll Everywhere what the Segments are doing to move "up and to the right." Some answers included reviewing meeting costs, not spending unnecessarily, trying to increase meeting attendance, reviewing pricing models, retaining high quality content. Anne also reviewed the Intended Impact Statement and the Impact criteria for scoring before asking for feedback on the Proposal Forms that will be used to project into the future the ways that each proposed project could support the organization and prioritize the projects based on both impact and financial implications.
- **D. Increasing Our Impact** Julie Smith David reviewed the published view of the Kudos dashboard and gave an overview of recent activity. She gave examples of how authors can post to various social media sites from within Kudos to help promote their articles that are posted on the Digital Library. Julie thanked the Intellectual Property Task Force III for their assistance with the Kudos project.

The Research Relevance Task Force is exploring how we can build stronger bridges with practice, how we might align our incentive structures with the need for our research to have an impact, and how we might modify our scholarly publishing practices to enable a broader type of content, questions, methodologies. The Task Force's recommendations for promoting research relevance were discussed, and Council gave feedback on additional ways to support and expand research relevance. Julie announced that Bill Ezzell, who had been a member of the Task Force, passed away on April 28, 2018.

E. Ideas for the August Council Meeting? – Markus Ahrens used Poll Everywhere to get feedback from Council members on potential topics for the upcoming meetings. Some suggestions were At-Large panels, more about Kudos (including handson sessions), how to expand membership, changes to membership classes and dues.
