Minutes November 16, 2020

- A. Welcome President Elaine Mauldin welcomed members to the meeting. The agenda was approved with no changes.
- **B.** Council Meeting Review/Action Items Council Chair Nancy Nichols led a discussion of the outcomes of the Council Meeting and activities.
- **C. Publications Update –** Vice President of Research and Publications Mark DeFond discussed the current AAA Journal Editors and AAA Membership Policy. The policy will remain as it is posted. As editors rotate, the Call will include that AAA membership will be required during their term of editorship.
- **D. Global Gathering** Director-Focusing on International Giorgio Gotti reported there were about 20 Global Gathering attendees at the Annual Meeting. There is a common theme that their Associations would like more involvement with the AAA. Giorgio will look into a date for a future Global Gathering.
